1. Outline

JOGMEC invites proposal for a “Drilling Cost Probabilistic Evaluation & Drilling Risk Evaluation Software”.

2. Contract

(1) Procedure

After the evaluation of proposals, the contract will be made between JOGMEC and the selected contractor.

(2) Duration

From the effective date of the contract to the end of 2009FY (31st, March, 2010)

(3) Budget

Maximum lump-sum budget is about US\$25,000 (JPY2,500,000, at US\$1 = JPY100)

3. General requirement

(1) Considerable knowledge and experience on the relevant technology is required.

(2) Applicants must be reputable and financially stable companies.

(3) Applicants must have suitable organization to complete and deliver this service.

4. Proposal requirement

Two hard-copy sets of all proposal documents (original and copy) must be submitted including as below,

- Cover letter (with signature of the representative)

- Technical proposal

Proposal must clearly indicate that the following items will be dealt with.

(a) Proposal for specification (Please make proposal **consistent with JOGMEC objectives.**)

(b) Utility and function for the software

(c) Customer service during the contract

(d) Company experience of this sort of service

- Quotation for total cost (A breakdown for each element of the work to be undertaken must be submitted. Quotations must clearly indicate the unit cost and the total cost.)
- Company information

5. Submission of Proposals

(1) Deadline

March 9th, 2009, 09:00 UTC (18:00 (JST))

- Proposal should arrive at JOGMEC Technology Research Center before the above deadline.
- Only proposals sent by registered mail or courier will be accepted.
- If the proposal includes any defects and they have not been modified by the above deadline despite JOGMEC's instructions, the proposal will be invalid.

(1) Proposal evaluation

The submitted proposal will be evaluated with the focus on the following criteria.

- > Consistency with the objectives of JOGMEC
- > Contents of proposal based on the specification
- > Company experience
- > Total cost

(2) Result

Result will be announced on JOGMEC's web site immediately after evaluation. Questions on the evaluation process will not be accepted after the result has been announced.

7. Contract

JOGMEC will discuss the details of the contract with the selected contractor and the contract will be finalized after mutual agreement. The attached file is just a sample.
